

WINTER EXPRESS TRIO TOURNAMENT RULES

1. The W.E.T.T. is NOT a USBC or IGBO sanctioned tournament, however it will be conducted under the USBC and IGBO rules.
2. W.E.T.T. 2010 is a team tournament consisting of three (3) games. Teams shall consist of three (3) bowlers of men and/or women. Men and women shall compete on an equal basis. Bowlers shall participate only once in this nine (9) pin no tap format event.
3. Participation in W.E.T.T. 2010 is limited to 40 teams of 120 bowlers on a first come, first serve basis. Reservations are official only after the receipt of the completed entry form together with the payment of \$105.00 (U.S. currency). Payment must be made with a money order or cashier's check payable to the "Ypsi-Arbor Lanes".
4. All entries must be post-marked no later than January 23, 2010. Hand delivered entries may be accepted after that date only in the event that space remains available. Acceptance in this tournament shall be determined by the order of receipt of the necessary forms and funds.
5. All bowlers entering W.E.T.T 2010 must use their highest USBC ten pin average. Failure to use the correct average shall result in disqualification from the tournament if the reported average is lower than the actual average. The following priority shall be used to establish bowlers entering average:
 - A. The highest current average as of December 31, 2009, (minimum 21 games) from a sanctioned league. This must be certified by a league secretary.
 - B. If none, the highest 2008-2009 yearbook average (minimum 21 games).
 - C. If none, the highest 2007-2008 yearbook average (minimum 21 games).
 - D. If A, B, and C do not apply, an entering average of 190 shall be used.
6. AVERAGE VERIFICATION MUST BE ENCLOSED!
7. All bowlers with a current sanctioned average (minimum 21 games) that is ten or more pins higher than their reported average must notify the Tournament Director at the time of entry for a possible re-rating.
8. Handicaps shall be established by taking 90% of the difference between the accepted average and 220. Negative handicaps will NOT be used.
9. The Tournament Director reserves the right to re-rate any entrant's average if reason warrants. This must be done before the bowler rolls frame one (1) of game one (1). Any bowler unwilling to accept an average adjustment is entitled to a full refund. Failure to correctly declare correct entering average may result in disqualification.
10. All team members must be present at the start of bowling. Registration begins at 1:00 P M. Bowling warm-up begins at 2:00 P M. Competition begins at 2:15 P M. Late bowlers must begin in the frame being bowled, with a score of zero (0) entered for each frame missed. Substitutes may be used at the discretion of the Tournament Director.
11. Prize moneys will be distributed immediately following the tournament and shall be at a pay out ratio of one (1) to five (5).
12. Claims of error or disputes must be made to the Tournament Director. The Tournament Director, together with the tournament committee shall adjudicate the dispute in accordance with W.E.T.T. 2010 and USBC tournament rules. Decisions are final.
13. Every bowler is automatically entered in the Mystery Game. The Mystery Game is based on the score from game one (1) and game two (2). Individual brackets and jackpots will be available at the time of registration.
14. In the event of inclement weather or power outage, W.E.T.T. 2010 will take place on February 20, 2010 (two weeks later).
15. Only tournament entrants and paid non-bowlers may join in the buffet.
